# **PRESIDENTIAL ADDRESS**

# To the 146th International Convention of the Theosophical Society, On-line from 27 to 30 December 2021

GREETINGS friends! I would like to welcome you all to this opening of the 146th Annual Convention of the Theosophical Society (TS). It is a very good thing to be together in this virtual manner once again.

Many of you will know that 2020 was a historic year for the TS in that it was the first *ever* fully virtual Convention of the TS in, at that time, its 145-year history. Conditions did not permit for a physical gathering even though during the courses of World Wars we somehow managed to have a physical gathering. But last year was different, it was historic!

When the history books of the future are written, 2020 will be a very exceptional year for humanity, and for human history, a watershed year, a tipping point. There are a lot of ways that we can describe it; there are many perspectives on it; but it is very clear that during that year something profound changed. There are many ways to interpret it, but from an Ageless Wisdom perspective, or even just from a level of a keen sort of observation, it is clear that there was something new. Through this pandemic that we are still experiencing, a global recognition was forced upon us of our interdependence without regard for financial status, educational level, race, caste, religion, sex, or colour.

No one stood outside of this shared human experience of a pandemic. Of course, it was largely a fear-based recognition for the safety of our loved ones and of ourselves — but it was recognized. Alongside of this particular global recognition issue, it seems as if there has been another rising recognition of a global sense of human responsibility for a planet that is simultaneously drowning and burning, resulting from the effects of human choices, human-induced environmental conditions over a period of time.

Now we are seeing what could be called "predictable", but dire, consequences or effects on the environment. There is a recognition that in spite of our past behaviours humanity does not stand outside of Nature. We are not separate from it, above it, or immune to the natural world. This is a dawning recognition, again, imposed upon us by the effects of global patterns that we are witnessing of weather shifting, and the models that have been developed to track their potential results. This is something new. The isolation, or separation, that we have fostered in our behaviours as nations and as individuals are at least coming into question. It is a very important moment of how we, as a human family, will respond — that remains to be seen.

Sometimes, as individuals, the slightest glimpse of a truth is lifechanging, direction-changing. But sometimes the sense is that the demands of truth, having seen something that is too demanding, make people respond differently, and then maybe distract themselves from what they have seen. In the words of T. S. Eliot: "We are distracted from distraction by distraction." So these are some of the possibilities.

H. P. Blavatsky (HPB), one of the Founders of the Theosophical Society, made an important statement in discussing the power of truth. She said: "There is no more fatal fallacy than 'The truth will prevail by its own force. It has only to be seen to be embraced." The fact, as she presented it, is that "The desire for truth exists in very few minds, and the capacity to discern it in fewer still." If one believes that this is a correct analysis, it means that for us members of the TS who believe in the motto of the Society that "there is no Dharma [or religion, or any system of thought] higher than Truth", there is a role for anyone among us who feels that there is value in seeking truth.

This is because it places a certain responsibility on us not only to seek for truth, but when some realization of the nature of a truth, or of truth comes to us, also to suffer it, to respond to its demands, and not go back to sleep. This is a serious need in the world and it is a duty for those who are so inclined.

From the perspective of this year's Convention and its theme,

the role for us is to live more fully, to live in the now, to learn, to see, and to accept the challenges of the inner life. With that as a prelude, at this time I would like to request you all to rise while I pronounce the traditional invocation to the Great Ones for beginning this Convention:

May those who are the embodiments of Love Immortal bless with their help and guidance this Society, founded to be a channel for their work.

May They inspire it with their Wisdom, strengthen it with their Power, and energize it with their activity.

At this point I declare this 146th Annual Convention of the Theosophical Society open.

The Indian Section, with the largest membership in the international Society, has 9,039 members (443 of them life members) in 480 Lodges and 13 study centers. A positive result of Covid-19 was the evolution of on-line lectures resulting in both an increase in audience attendance as well as the discovery of new speakers, many of them young theosophists. The new college building was completed with an additional capacity of 300 students, and there are plans to expand the scope of courses offered to the management and education streams. The Besant Education Fellowship managed two schools in the Section's headquarters campus. An inperson meeting marked the celebration of Dr Annie Besant's birth anniversary, whereas Foundation, Adyar, and White Lotus Days were celebrated in on-line meetings. After giving the opportunity for life members to confirm their presence for continued membership, 745 out of 1,188 were dropped due to lack of response. This contributed significantly to the overall membership drop of about 14% from the previous year.

The 129th National Convention-II was conducted on-line in December on the theme, "Awareness Transforms Life", chaired by Vic Hao Chin, Jr, former General Secretary of the TS in the Philippines, and a master of the subject. The first Public Lecture in memory of Radha Burnier, the 7th international President of the TS, was held on THE INDIAN THEOSOPHIST, Feb./2022/87

30 October, with the keynote address, "Radhaji: Glimpses of Her Life and Influence", attended by 90 global participants. The 97th Easter Conference (originally called South India Conference) was held online in April with 250 registrants (68 from outside India), on "Theosophy and J. Krishnamurti". The consensus was that, far from being contradictory, Krishnamurti's teachings were an affirmation of Theosophy. Of the 16 Federations, seven held on-line annual conferences and three in person. One was the Telugu Federation's centenary celebrations planned for March 2020, which had to be deferred and was held one year later. There were 100 delegates and 150 members of the public participating.

The annual study camp was conducted on-line, directed by Ven. Olande Thero, on "Mindfulness, the Heart of Buddhist Meditation", with 100 participants. No study camps could be organized at the popular Himalayan study centre at Bhowali. Over 80 study classes were held on-line on *The Mahatma Letters to A. P. Sinnett* and other theosophical books. Numerous special lectures, seminars/workshops, and other programmes were conducted in English and Hindi, mostly by over 15 national lecturers. Overall, propagation of Theosophy was the highest in decades due to the extensive use of online media. The TOS continued its activities like women's empowerment, subsistence and treatment support for Covid19-affected economically disadvantaged families, cyclone relief, and so on.

The International Vice-President, Mrs Deepa Padhi, was invited to chair the 129th Indian Section Convention-I in December.... The 56th annual conference of the Utkal Theosophical Federation in September on "Humanity and Beyond" had her as the chief guest.

At the **International Headquarters** of the TS in Adyar, Chennai, India, the Administrator of the **Adyar Theosophical Academy** (ATA), Mrs Sonal Murali, reports that the second academic year continued on-line due to the ongoing Covid-19 pandemic, and started its third year in June with 130 students from Nursery to Grade 88/THE INDIAN THEOSOPHIST, Feb.,/2022

4. The anniversary was celebrated on-line with President Tim Boyd as the chief guest. At the crux of the ATA student/teacher interaction is transformative learning. A typical day begins with "circle time" when children bring to the table what they would like to share and build on via organic conversations. Arts and crafts in many forms continue to be explored, whether Form Drawing or Mandala Art. During the year, a successful link with Nature and its wonders was achieved for children from home through Nature Journaling. Language acquisition in Tamil and Hindi grew steadily using games, stories, and music. Theatre classes instil skills like good communication, coordination, and group work.

A Science Hub was launched for students to actively engage in experimenting, designing, and querying. This is not to omit school events like creating music, Science Day, and Annual Day with plays and songs. Teachers had regular, skill and knowledge upgradation programmes in areas like systems thinking, stages of development, multiple kinds of intelligences, non-violent communication, and contemplation of the core question: "What is education for?"

The Officer-in-Charge of the Surendra Narayan **Archives**, Ms Jaishree Kannan, reports that no researchers could visit the Archives during the pandemic, but there were fifteen research scholars using its resources on-line. Their requirements were catered to by scanning or copying the materials available. The 17th of February 2022 will mark the beginning of the centennial year of the Archives, and they are gearing up for this important landmark by having a year-long programme starting with the International Convention 2021.

In the Adyar **Museum,** Dr Bernd Jesse continued his valuable voluntary work. The Venkatachalam Collection consists of over 100 early 20th-century paintings and Hindu bronzes, in various states of preservation. Cleaning and identification of these artefacts is in progress. Photographing these items has consumed more time than previously thought, so the immediate focus is on the more prominent pieces. This includes several other items in the display room as well.

The Theosophical Publishing House reports that during the

year, book sales were Rs. 1.8 million with royalties accounting for Rs. 0.8 million. This was lower than earlier years due to the Covid19 disruption and also to some options for e-books rather than the printed version. Still, 44 book titles, many of which were out of stock, were reprinted; 22 book titles were scanned and converted to the soft copy format. Subscribers to *The Theosophist*, a monthly, were 864, of which 612 were Indian. The quarterly *Adyar Newsletter (ANL)* had 372 subscribers (256 in India). Apart from the periodicals, **Vasanta Press** continued to print titles ordered by TPH and Adyar Library. They also printed 9 book titles, 11 issues of *The Theosophist*, and 4 issues of *ANL*.

The **Theosophical Order of Service** (TOS) is present in 36 of the 59 countries where the TS is active and has several outreach avenues, per Ms Nancy Secrest, TOS Secretary. The TOS: in-touch. on-line e-newsletter is published quarterly. The website is <international.theoservice.org> and the Facebook link is <facebook.com/tosinternational>. Covid-19 created restrictions, but ironically allowed many more people to interact via on-line talks accessible worldwide. On-line activities were held from India and the Philippines. Due to retirement, new Directors were elected in Argentina, Mexico, and Bolivia. A large donation was received from TOS England for Covid-19 relief in India, used to distribute food and household articles in several cities. Face masks, hand sanitizers, and oxygen tanks were some items distributed for Covid relief. A few Adyar employees were also helped with medical costs or replacement of loss of spousal income due to the lockdowns. Many TOS groups around the world helped those who needed food, medical, education and other assistance. Regular projects were mostly maintained. Assistance with various women's issues, educational and scholarship efforts, and youth involvement remained central issues for many groups, along with animal welfare, and humanitarian assistance. Also, almost all countries have healing groups.

# **NEWS AND NOTES**

## Bengal

The 108th Anniversary celebration of the Bally Theosophical Lodge was held on 21 November 2021, at Sishu Samity Hall, Goswamipara Road, Bally, Howrah. Joydeb Goswami read out the activity report of the Lodge. Prof. Prahlad Kr. Sarkar, Ex. Hd. of the Deptt. of Philosophy of Calcutta University, in his presidential address beautifully explained the origin of "Brotherhood" as propagated by TS, the contribution of Dr. Annie Besant to the Theosophical movement in India and the efforts made by her for spreading education specially for women. Bro. A.M. Patra , narrated the significance of "Golden Stairs" of Madam H.P. Blavatsky. Shri S. Banerjee, (invitee), Shri A. Banerjee, Bro. H.K. Halder, Bro. P.K. Ghosh, Bro. S. Chatterjee also spoke on this occasion. The meeting ended with the vote of thanks given by Bro. J. Goswami.

#### Kerala

An on-line meeting was organized to celebrate the Foundation Day of the Theosophical Society on 17 November 2021. Federation's President Dr. M.A. Raveendran presided. Meeting commenced with Universal Prayer. Bro. K. Dinakaran, Secretary, K.T.F., welcomed the members and speakers of the day.

Dr. Raveendran in his Presidential address mentioned the importance of the Foundation Day and narrated the events which took place before the formal inauguration of the Theosophical Society by Col. H.S. Olcott.

Sis. Laxmibai of Annapoorni Lodge, Alleppey, spoke about the glorious life of Madam H.P. Blavatsky. She pointed out that when an option was put before her by her Master whether she would like to complete *The Secret Doctrine* or release from the torturing illness of the physical body, she desired to complete *The Secret Doctrine*. Her care for the poor, sacrificing all comforts in life is a shining example of her greatness.

Dr. Beena of Sri Sankara Lodge, Ernakulam, spoke on H.S. Olcott the founder President of T.S. H.S.O. was a lawyer, agriculturist, writer, journalist, Healer and a great Theosophist who sacrificed worldly comforts and sacrificed money, time and energy for the cause of Theosophy. Bro. N. From January 2022 onwards, two talks in this series will be arranged on the second and fourth Sunday of every month.

**Programme for students/teachers/ youth:** A sixteen weeks course on 'Self-realization through Theosophy' has been introduced to add value to the regular courses of all disciplines taught at UG and PG levels in Vasant Kanya Mahavidyalaya, Varanasi. The curriculum for this course emphasizes on character building aspects, life skills, imbibing right values and practicing right behaviour. The course aims at helping the students to ptrepare for challenges of life and get ready for the future with internal peace, happiness and virtues of right behaviour. 125 students got enrolled for this course. The resource persons for this course are: Smt. Uma Bhattacharyya, Bro. V. Narayanan and Bro. Shikhar Agnihotri. The first two sessions were conducted by Bro. Shikhar Agnihotri on 20 and 27 November, 2021 on the topics 'Theosophy and Fundamentals of Indian Philosophy' and 'Law of Karma and Man is maker of his own destiny' respectively. Besides, a session on 'Thought Power' was conducted by Bro. Agnihotri on 4 December.

# Guidelines on Abolition of Admission Fees and Annual Dues

The annual dues from members and admission fees for new members to the Indian Section have been abolished effective from 1.1.2022 through a constitutional amendment passed by the Indian Section Council on 20.12.2021 and approved by the International President on 27.12.2021. A New Member Admission Form has been sent to all Federation Secretaries and uploaded on the Indian Section Website.

- 1. A copy of the Aadhar Card properly signed by the applicant must be attached with the Admission Form which too must be signed by the new member; he/she must specify whether the free copy of "The Indian Theosophist" is required in English or Hindi, must have a full and detailed residential address, email address or a "care-of" email address, telephone number or "care of" telephone number and a latest photograph, without which membership will not be approved.
- 2. Every existing member must send an email to the Indian Section Headquarters at "renewalindsecmem@gmail.com" before 5 pm on  $30^{\text{th}}$  September every year as per the format given below which must have their signature. The same is applicable for life members.

The fully filled, signed and dated copy of the above format must be scanned and sent to the email address given above between 1 July to 30 September. Copies sent by post will not be accepted.

- 3. One copy is sufficient for all family members living at the same place but all T.S. members must sign it.
- 4. A Lodge (not a Federation) can take the signatures of its elderly members on one page in the format given above, scan it and send it to email address given in item 2.

- 5. The members will not be required to pay any International Dues or Federation Dues. However, they will be required to pay Lodge Dues, if any. There will not be any life membership for Lodges.
- 6. There will be no annual subscription of The Indian Theosophist but every member must specify whether they want it in English or Hindi.
- 7. Starting from April 2023, every Federation will get Rs 75 per member (not counting the life members) as of October 1 of the previous year for propagation of Theosophy. The membership figure given on ISMS will be considered final. Hence, Lodges and Federations should check the figures in the first week of September and sort out any discrepancies with the Indian Section. The allocation of money for life members to the Federations will be as per earlier practice. Audited accounts of propagation expenses must be maintained and sent to Indian Section in Feb. to qualify for any further money from the Indian Section.
- 8. Every Lodge must maintain a register of its members having a Diploma, keep a record of their presence and maintain record of dates on which lodge meetings took place along with the subjects discussed.
- 9. It will be the primary responsibility of the Lodge Secretary & President and the Lodge Council to ensure that any new member that is taken is proper, does not have any unpaid past dues and is worthy in every respect of membership to the Theosophical Society.
- 10. Federation will not have to send any ADS from now onwards except that for members who have pending amounts against their name as of 1<sup>st</sup> October 2021. However, they will have to forward new member application form to the Indian Section office after due verification of the credentials of the new members.
- 11. Federations will have to report to the Indian Section Office by  $30^{th}$  September every year the names of the members (including life members) who have 'Gone to Peace' and those who have resigned from membership during the last 12 months.
